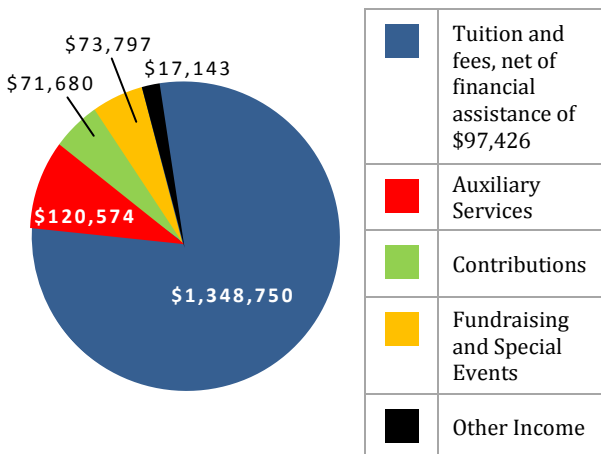

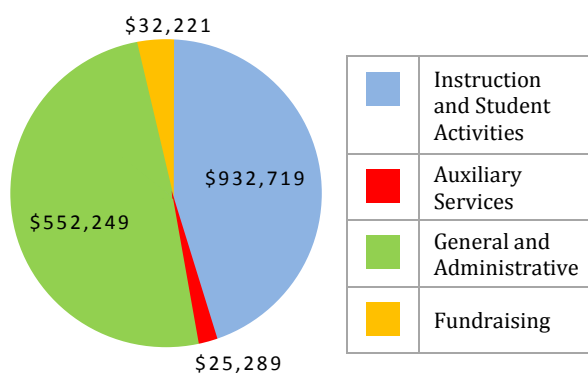
Revenue
